## 9. Church update

A Heritage Lottery grant has been turned down for the work on the Tower. Further grant applications are being pursued. Cllr. A Kirkbride stated he was not in favour of the rendering of the Church Towe,r which dates back to the 1400c, which has never been rendered. He believes the best option would be to have it pointed.

Cllr. Teasdale said in his opinion the Tower had never been rendered as you would have seen from how the mullions were set. His professional view was that should the rendering crack, then water would get behind and bring the rendering off. The best solution would be to point the Tower.

Cllr. A Kirkbride reported that A Craske would be replacing a new flood light post.

## 10. Askrigg Foundation Building

The Trustees have been able to award the building contract for the two flats and a small cottage, plus refurbishment of the retail unit to Neil Dinsdale of Hawes. The work is expected to start in April and could take approximately 24 weeks to complete. Asbestos removal will begin on Monday 17<sup>th</sup> February and should take two to three days. Planners are refusing to allow the installation of wooden double glazed windows, insisting on the current ones being repaired. The Trustees believe this is not a viable option for affordable housing and negotiations are underway to try and resolve the situation.

## 11. Healthwatch

The consultation is still ongoing around the future of the Friarage Hospital. The minutes of the Healthwatch meetings is that the Tuesday evening appointments at Aysgarth are not being fully utilized and people should be encouraged to use them.

## 13. School boundary fence

A meeting with the school and the wider community had taken place to discuss transport etc., however, no one from Askrigg was able to attend. Cllr Fawcett said the meetings were arrange during the day whenit was difficult for people to attend.

The hedging opposite the tennis courts had still not been trimmed. Cllr A Kirkbride said this was the Yorebridge Foundation responsibility and suggested the Clerk contact Christine Lambert.

#### 14. Dog Fouling

Dog fouling continues to be a big problem in and around Askrigg. Cllr Fawcett said he was not happy that most of the meeting was taken up discussing this issue. He also added that he had received a number of complaints, over Christmas, of dogs roaming and that photos and videos had been taken.

An email had been received from a group of parents complaining of dog fouling on the pavements from the village down to the school. The Clerk suggested involving some children to design some signs which could be placed on the way down to school. Councillors supported this suggestion and Cllr Hodgson said he take this forward.

## 15. Speed Matrix

The Clerk reported the sign does slow some drivers down. A member of the public asked about the use of batteries rather than a solar panel. The Clerk said the solar ones were not recommended as they were heavy to change locations.

Cllrs A Kirkbride and Hodgson agreed to attend the next meeting on 10 February 2020 at West Burton.

#### 18. Any Other Business

A letter has been received from the occupier of Beech House regarding the lane at the back of the houses towards Seta Barn being very slippery after rain and in Winter. The Clerk to contact the Ranger as the footpath is YDNP responsibility.

An email, from a local resident, had been received asking that farmers be alerted to the damage and effects of plastic wrapping in fields etc. has on the livestock and environment. Whilst the Councillors appreciated the concerns it was felt not there responsibility.

A member of the public said she was concerned over fumes going into her kitchen at the bottom end of Silver Street. The Parish Council said they would try and find the source.
