Local resident, Jill Leslie, told the meeting that there has been an increase in certain areas. The Clerk to contact the local ranger to seek permission to display a sign near the bridleway from the top of Silver Street towards Becks Bits.

15. Speed Matrix

The sign is now installed. Some drivers are taking note and slowing down others are not. The batteries are not lasting very long before they have to be recharged. This is probably because some drivers are taking no notice of the sign.

18. Any Other Business

A resident raised concerns over the number of parking cones being used to `protect' parking spaces. Also there are safety concerns because of vehicles being parked on the paths and on both sides of the road. This is restricting walking on the paths, particularly for older people and those with prams. A question was raised about renting space on the old Carrs Billington site. Cllr Peacock informed the meeting that a feasibility study was to be carried out on the site which would be fed into the local plan

The Clerk was asked to write to the Parks regarding planning consent for the building work at West Leigh on the West End.

There appears to be a number of Ingrid Flute signs being put outside holiday properties. Cllr. A Kirkbride to find out if these are acceptable, particularly in the conservation area.
